



Fiscal Year 2022 Community Benefits Plan Report Summary

Shirley Ryan AbilityLab, formerly known as the Rehabilitation Institute of Chicago (“RIC”), is the global leader in physical medicine and rehabilitation for adults and children with the most severe, complex conditions – from traumatic brain and spinal cord injury to stroke, amputation, cancer-related impairment, and complications associated with COVID-19. Shirley Ryan AbilityLab is a 501(c)(3) nonprofit corporation, as defined by the Internal Revenue Code. It expands and accelerates leadership in the field – leadership that began at RIC in 1953. The quality of its care has led to its designation as the number-one rehabilitation hospital in America by *U.S. News & World Report* every year since 1991. No other hospital, of any kind, has held this distinction for as many consecutive years. Shirley Ryan AbilityLab provides a continuum of care, offering inpatient, outpatient, and day rehabilitation (“DayRehab®”) services.

In fiscal year (“FY”) 2022, Shirley Ryan AbilityLab treated 3,603 inpatients and 16,100 outpatients and day rehabilitation patients. Shirley Ryan AbilityLab facilities are staffed by approximately 2,500 clinicians, scientists, researchers, medical professionals, and support personnel – an integrated and dedicated team – which has treated patients from nearly every state in the nation, as well as from multiple countries around the world.

Charity Care, Financial Assistance and Community Benefits Spending

Shirley Ryan AbilityLab offers financial assistance to qualifying Illinois residents by fully or partially waiving patient financial obligations for medically necessary services. Individuals who may qualify for financial assistance are invited to submit an application. Each application is reviewed, and decisions are made based upon objective, needs-based criteria.

Shirley Ryan AbilityLab also funds numerous community benefits for multiple underserved populations — benefits that would not exist without Shirley Ryan AbilityLab’s support. Initiatives include LIFE Center education and outreach; an adaptive sports program, which is comprised of recreational and competitive sports programming for children and adults, sports and fitness center programming, and military sports programming; patient peer support groups; education for healthcare providers; and innovative medical research. In the process, the organization has established a vast network that promotes care, education, healing, and community among those with functional impairments.
